The CSA runs from June 3 through November 25, for a total of 26 weeks. Or, choose your own delivery weeks - minimum of 10 weeks. Pick up your Blooming Hill Farm organically grown produce on Wednesdays from 3:00 pm to 6:00 pm at 128 Elbert Street in Ramsey (on the corner of Elbert & Warren Streets - driveway off Warren Street).

WHAT IS THE CSA?

Community-Supported Agriculture (CSA) is a mutually beneficial partnership where consumers receive fresh produce while helping to sustain the livelihoods and stewardship of farmers. The farmer pre-sells "shares" of his or her farm's upcoming harvest.

CSA SHAREHOLDER REGISTRATION

As a member of the CSA, I will receive a weekly share of in-season organically grown produce. The shares will vary in size and weight depending on the time of the season and will also include herbs and seasonal fruits. One aspect of a CSA is that members support their farmer by sharing in the inherent risks of agriculture (poor weather, drought, disease, early frost, crop failure, etc.) and rewards (the bounty of a good season). CSA farmers purposely plan for such contingencies and use growing techniques that protect the harvest, minimize risk to members, and optimize the rewards by growing a wide variety of crops that thrive in different types of conditions, cover cropping, crop rotation and irrigation. Therefore, I understand there is no guarantee on the exact amount or type of produce I will receive in my share. By participating in this CSA, I am supporting the local farmer as well as a more equitable food distribution system, and I am helping to create a more environmentally just, economically fair, and healthy society.

I commit to picking up my weekly delivery in Ramsey between 3:00 pm and 6:00 pm on **Wednesdays**. I may split my share with other people, but they must provide the shareholder's name listed on this form at pick up. I may make special arrangements for my share to be picked up in my absence. I understand that if I do not pick up my share, it may be donated to the Center For Food Action.
